The New Mexico State Legislature



The New Mexico Legislature is made up of 70 members of the House of Representatives and 42 members of the Senate. The speaker of the House presides over the House, and the Lt. Governor presides over the Senate.

Representatives must be at least 21 years old, and Senators must be at least 25 years old. All legislators must be citizens of the United States and live in the district from which they are elected. Legislators are elected from districts of approximately equal population.

Members of the House of Representatives are elected every two years, and Senators are elected every four years.

By law, the New Mexico Legislature convenes in Santa Fe each year on the third Tuesday in January. Sessions last for 60 days in odd-numbered years and 30 days in even-numbered years.

New Mexico's citizen-legislators are volunteers and receive no salary for their services to the state. Other than a per diem, mileage allowance for attending legislative sessions and interim committee meetings, the constitution of New Mexico specifically prohibits any other compensation, perquisite or allowance. Their offices are only staffed during legislative sessions, with the exception of the Leadership of both the House and the Senate.

The Legislative Council Service and the Chief Clerks of both the House and Senate provide services to the legislators year-round, such as bill drafting, research and constituent services.

The Basics of Grassroots Lobbying

What is Grassroots Lobbying?

Lobbying includes all attempts to influence [legislators](#) and officials, whether by other legislators, [constituents](#) or organized groups.

Grassroots lobbying efforts are well known for getting the job done by pushing change from the constituent level on up to the top decision makers. Grassroot campaigns are defined as being “natural and spontaneous, highlighting the differences between this and a movement that is orchestrated by traditional power structures” (Wikipedia, <http://en.wikipedia.org/wiki/Grassroots>).

In grassroots lobbying, the constituent is the key. Legislators will often prefer to hear how a constituent feels about a certain piece of legislation than to hear from the organizations that are in favor of or opposed to the issue. In this respect, individuals play the ever important role of conveying their opinions, or the opinions of the group, directly

10 Tips for Lobbying Legislators

1. Always be respectful.
2. Always be kind to the legislator's staff.
3. Be brief. short, sweet and to the point.
4. Understand your issue. Research beforehand if necessary. Legislators and staff rely on you to know what you are talking about
5. Have your comments written out beforehand, this way you make sure to cover all of your points in the short amount of time you have.
6. Communicate clearly.
7. Be patient.
8. Be calm.
9. Have the courage to stand up and let your voice be heard.
10. Check your politics at the door. Be concerned about the issue. It doesn't matter if they are a republican or a democrat, it matters if they vote for your issue.

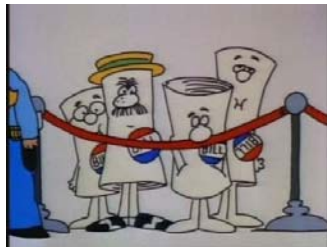
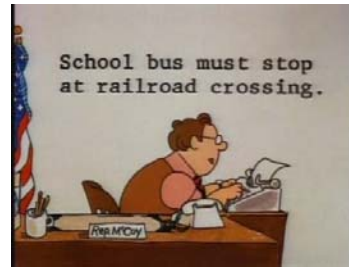
The Basics of Grassroots Lobbying

How a Bill Becomes Law



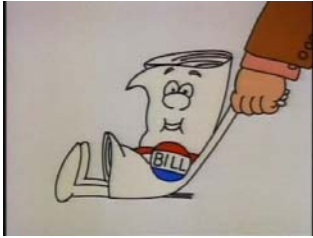
A bill is usually written based on a certain need in a community. Such as, the need for a school bus to stop at a rail road crossing. Constituents contact their legislator to get the legislation drafted.

A bill may be introduced in either the House of Representatives or the Senate. Once the bill is introduced it is read twice by title and given a committee assignment.



The bill is then sent to committee for consideration. The committee meetings are generally open to the public. Here the legislators listen to public testimony and can amend the bill. The bill moves forward to the next committee after receiving a do pass or a do pass without recommendation. The bill can also be tabled in committee or given a do not pass.





After making it through the committee process, the bill is ready to be heard on the floor. This is called Third Reading of Legislation. Here the bill is put on final passage and the entire membership of the chamber gets to debate the bill, amend it or substitute it. However, the purpose of the bill cannot be changed.



Once the bill passes the chamber it was introduced in... it goes to the other chamber and the process starts all over again.



After passage by both houses, the bill is enrolled and engrossed and sent to the Governor's desk to be either vetoed or signed into law.

If the Governor vetoes a bill, the House and Senate can override the veto with a 2/3 majority in both houses.

Once the Governor signs the bill, if the bill carries an emergency clause, the bill becomes effective immediately. Otherwise it becomes effective 90 days after the legislature adjourns.



Legislation, Committees & Action

Bills

A *bill* is the form used to propose laws. A bill may originate in either house, but in order to become law, it must be passed by both houses and signed by the Governor. By custom the General Appropriation Act, which appropriates the money to fund state government, originates in the House but there is no legal requirement that it do so.

Memorials

A *memorial* is an expression of legislative desire that is usually addressed to another governmental body in the form of a petition or declaration of intent. For example, a memorial may ask the Department of Transportation to build a road in a certain part of the state or a legislative interim committee to study a particular issue. Joint memorials are passed by both houses; simple memorials are an expression of only one house.

Resolutions

A *resolution* is a formal declaration of the legislature concerning some subject that it either cannot or does not wish to control by law. Resolutions are joint, concurrent or simple, and they require no action on the part of the Governor. A joint resolution can be a declaration by both houses proposing an amendment to the Constitution of New Mexico. Joint resolutions are also used to express the will of the legislature, such as in approving the sale, trade or lease of state-owned real property. Concurrent resolutions are used for the purpose of adopting or amending joint rules of the legislature. Simple resolutions are seldom used.

Writing or Emailing Your Legislators

Writing letters or emailing can be a very effective means of making your legislator aware of your opinions on legislation. Write to your legislator before or during the time the matter is being considered, and do not hesitate to write to the chair of a committee that is considering a bill you are interested in, even if he or she is not from your own district.

Talking With Your Legislators

During session, your legislator will be extremely busy. Consider making an appointment in order to make your visit successful. However, sometimes it is difficult for the legislators to set exact times to meet with you. Their staff may be able to give you an approximate time that would be best. State your facts as clearly and as briefly as possible and give specific examples to support your opinion. Be willing to listen to the

Calling Your Legislators

Sometimes it is difficult to get to Santa Fe to speak directly with your legislators and there may not be enough time for them to receive your letter. In this case a quick phone call to your legislator may be necessary. Due to the fact that the legislators are very busy during session, you may not get the chance to speak to them directly. In this case, leave a short but detailed message with the legislator's staff asking that the legislator support or oppose a certain bill. It will be very important for you to know the bill number, who is sponsoring that bill and what the bill does.

The Legislature's Web Site

The New Mexico Legislature's web site (www.legis.state.nm.us) offers a wide range of information. You may view a legislator's contact information and find legislation, calendars, agendas and other information on important issues facing the state. By entering your home zip code, you may identify the legislator who represents your district. You may also contact the legislature through the web site.

What Should You Say in a Letter, Email, Phone Conversation or In Committee?

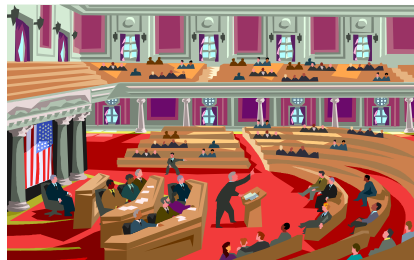
Address the written correspondence to The Honorable _____ State Senator or State Representative.

In Committee: Always address the chair first, "Mr Chairman or Madam Chair, Members of the Committee... My name is _____,"

State the Bill Number and Title of the Bill you are writing about, or standing up to support.

State whether you are writing, or standing, in support or opposition to the Bill.

State your desire clearly. Make a brief mention of how the Bill in question will impact you or your business.



A Few Simple Rules...

should be observed when visiting the legislature:

- No applause or loud talking in the galleries and committee rooms.
- Food or drinks are not allowed in the galleries and committee rooms; however, during session there is a public coffee shop on the ground level.
- Visitors are not permitted on the floor of the chambers while the legislature is in session.
- Smoking is not allowed in the building.
